## **Good practices**

- OBy creating its own unique brand logo, the HOKKAI-GAKUEN UNIVERSITY Communication Mark, not establishing rules for use of the logo, and allowing it to be used freely and creatively, the university is uniformly publicizing its individuality and distinctive qualities to society. These initiatives are worthy of evaluation.
- Ocareer Support Center staff collaborate with the Federation of Hokkaido Chamber of Commerce and Industry and carries out discussions about concrete information, such as corporate systems for accepting graduates, etc. These initiatives are worthy of evaluation.
- In order to achieve its educational objectives in accordance with its founding principles, the university holds a range of lectures rooted in the local region, such as Study of Hokkaido and Center for Development Policy Studies Special Lecture. These initiatives are worthy of evaluation.
- OExchange training for staff of the Incorporated Educational Institution Hokkai-Gakuen and the National University Corporation Otaru University of Commerce provides broad training related to university operations that transcend the framework of installation form. Including the achievement of establishing the Hokkai-Gakuen University Press as a result of discussions concerning university presses, these initiatives are worthy of evaluation.
- Equal research fund amounts are distributed without differentiating among researchers' job positions, and the fluid usage criteria for budget implementation are very effective for young researchers as they enable the improvement of research equipment and expansion of research fields. These initiatives are worthy of evaluation.

| Recommendations for improvement  |
| OWith regard to the items prescribed under Article 93, paragraph (2) of the School Education Act, the Graduate School Regulations does not stipulate that the Graduate Program Committee and Graduate School Committees are to express their opinions when the President is making a decision. Accordingly, improvements are required.   |
| OWith regard to those important points regarding education and research prescribed under Article 93, paragraph (2), item (iii) of the School Education Act for which the President stipulates that the opinions of the Graduate Program Committee and Graduate School Committees must be heard, the President has not stipulated or disseminated any points; accordingly, improvements are required. |
| ONone of the items related to the status of faculty training stipulated under Article 22-6 of the Regulation for Enforcement of the Education Personnel Certification Act have been publicly disclosed, and improvements are required.   |
| OThe status of execution of directors' duties is not being recorded in the audit and audit report by auditors as required under Article 13, paragraph (1), items (iii) and (iv) of the articles of endowment. Accordingly, improvements are required.  |
| OImprovements are required with regard to some matters concerning the disclosure of information in accordance with the law, functionality of education and learning management, and execution of auditors' duties, and it cannot be said that internal quality assurance is functioning sufficiently. Accordingly, improvements are required.  |
