Good practices

- There are plenty of courses for career guidance making the most of the specialties of the Faculty of Law such as the Police Officer & Fire Officer Class, Public Servant Examination Course, Certified Administrative Procedures Legal Specialist Course, Judicial Scrivener Course and other courses. Among these the Public Servant Examination Course offer a particularly wide range of programs, study guides based on the various types of occupations students wish to pursue have been created, the convenience of student course selection is attempted and meticulous guidance on sitting examinations is provided. These initiatives are worthy of high evaluation.
- In the light of the fact that the university is implementing education with a low student-teacher ratio, in addition to specialized and integrated consultation points, by collaboration among consultation points according to the needs of those consulting, multifaceted support is provided and a support system in which consultation can be obtained anywhere has been created. This initiative is worthy of evaluation.
- O Based on the results of student satisfaction surveys, the executive branch of the students' association compiles reports on the opinions of students in general, and a mechanism has been created for students themselves to be actively involved in the process of ascertaining students' requests. This initiative is worthy of high evaluation.
- With regard to the Questionnaires for Teaching Improvements, the questionnaires are designed so that the questionnaire results for each course can be cross-tabulated and analyzed by the faculty members in charge, and through the sharing of questionnaire results and feedback from each faculty member by both students and the entire faculty and staff, a contribution to educational content/methods improvement is made. This initiative is worthy of high evaluation.
- A President's Office Council has been established consisting of, in addition to those playing

important roles in each education and learning division, the Vice Chair of the Board of Directors and the Secretary General, the council serves as an auxiliary body for the resolution of important problems affecting the entire university, and a system has been developed under which the President's leadership can be exercised. This initiative is worthy of evaluation.

- The Faculty Development Committee is participated in not only by full-time faculty but also full-time staff, an environment enabling the reflection of opinions from positions of other than faculty is maintained, and the university is working towards improved education quality across its entirety. This initiative is worthy of evaluation.
- In line with the Incorporated Educational Institution Kimitsu Gakuen Internal Audit Regulations, the Internal Audit Office has been established, and as well as assigning dedicated staff and implementing audits in line with the audit plan, the Internal Audit Office Chief exchanges information with the auditors and accounting auditor, and the audit system is being strengthened. These initiatives are worthy of evaluation.
- The Seiwa University Disaster Prevention Regulations have been established in line with the Incorporated Educational Institution Kimitsu Gakuen Crisis Management Regulations, and a Self Defense & Disaster Prevention Squadron stipulated; in addition to evacuation drills fire-fighting drills are implemented and system to secure safety has been created. These initiatives are worthy of evaluation.
